(We encourage 6th, 7th and 8th graders to wrestle with the middle school program)

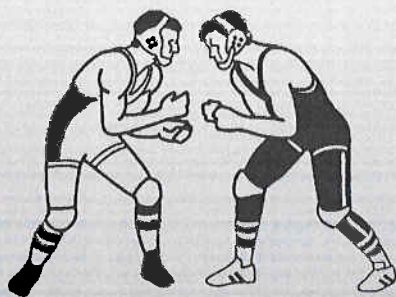

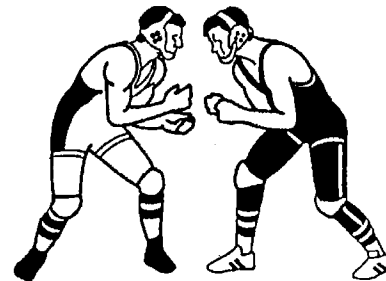
